A. NPA Staff Presentation (Budget) & Survey Update Dave Lykins Superintendent Lykins shared the Staff Presentation and Survey with the Board. As of March 14th, course card data entry was ongoing. On April 2nd, initial contract will be distributed to the faculty. A revised contract will be distributed after the State Legislature provides a decision on funding. Based on the Survey Results, the staff had three priorities to improve efficiency and equity. The priorities included increasing 9th and 10th grade enrollment, reducing ILS for seniors, and utilizing natural attrition. Details of the presentation are available in the PowerPoint presentation, slide numbers 4-26. Per Toni Keberlein and Steve Danner, the staff had a feeling of relief and calmness.

B. 8th Grade Retention Survey

Toni Keberlein

Principal Keberlein shared the results from the 8th Grade Retention Survey. Of 103 families, 76 families responded to the survey. If the decision to stay at NPA was solely up to the students, 76% of the respondents would likely stay. If the decision to stay at NPA was solely up to the parents, 96% of the respondents would likely stay. Per 77% of the respondents, the decision to remain at NPA is determined at the beginning of the academic year. Reasons that the families intend to stay are small school, class sizes, and caring environment. On the other hand, athletics is the primary reason for students leaving NPA. Board members made recommendations on promoting the athletic programs and expanding athletic opportunties to 8th grade students. Also, Board members made a recommendation to promote the Dual Enrollment and CAVIAT programs on the website.
